## Aftercare Polices

• Full time after school care students that are enrolled in extracurricular activities (i.e. sports, theater, etc.) may take advantage of the extracurricular dismissal rate. \*Students at this rate may only attend after care a maximum of 15 school days per month.

- Early bird rate applies to students enrolled in full time after school care with a pick up time of no later than 4:00 p.m.
- Drop-in students will receive an invoice on the first of the month for drop-ins used the month prior.
- On days of school delay, a.m. care will begin at 8:00 a.m. If you are enrolled in the before school program, you will pay an additional \$10.00. If you are a drop in not enrolled in the Before School program, the rate is \$30.00.
- If an early dismissal due to weather, etc. there will be no aftercare available all students must be picked up as soon as possible.
- On days of scheduled early dismissals, care will be provided for the registered students until 3:00 p.m.
- There will be no Before/After Care on days the school is closed for holidays or professional development.
- Payments are due as stated on invoices. A late charge of \$25.00 will be added to invoices
  more than 30 days late. Failure to make timely payments may result in denial of
  participation in the Before & After School Program until account is brought current.
- Each day, our program will include a snack, outside play, and homework time for older children. Children are responsible for making sure they have their assignments. Parents are reminded that they should check and review all homework.
- In the event that the school is closed for more than five (5) days due to inclement weather, a 25% discount will be applied to all full-time student next month's tuition statement.
