Payment of Tuition:

1. The undersigned agrees to pay tuition for the entire school year.
Parents shall select a payment plan for tuition from among options set through our tuition management program (FACTS). All tuition payments shall be made in accordance with the payment plan.
2. If a tuition payment is thirty (30) calendar days overdue, Most Blessed Sacrament Catholic School may impose any or all of the following sanctions, at the school's sole discretion, unless special payment arrangements have been made in writing signed by the school Principal. Sanctioned actions include:
 - a. Disallowing Student's participation in extra-curricular activities.
 - b. Withdrawing student from school.
 - c. Use a collection agency.
 - d. File a claim in court.
3. A family with an unpaid balance for the current school year may not register for the following school year until the tuition for the current school year is paid in full, unless special arrangements have been made in writing.

Refunds:

4. If a student is withdrawn during the school year, remaining tuition through the end of the year must be paid in full unless the School Principal agrees in writing to refund a portion of the remaining tuition. Otherwise there will be no refund, credit, or reduction for withdrawal, absences, vacations, snow days, illnesses, holidays, or moving.
5. If the student is asked to leave or withdraw from the School, the undersigned is responsible for the prorated annual tuition through the end of the month which the Student withdraws.



General Terms and Conditions:

6. **For New Families:** Prior to completing the registration process, payment of a non-refundable fee to cover the application for admissions in the amount of two hundred and fifty dollars (\$250.00) **per student** is required. The fee is non-refundable for any reason, including but not limited to, a denial of a student's application.
7. **For Existing Families:** A non-refundable tuition down payment of one hundred dollars (\$100.00) PER STUDENT is due along with the signed re-registration form contract by February 7, 2020. **The tuition contract for the 2020-2021 school year is distributed once the tuition schedule is determined. Re-registration is a crucial part of the finance committee's decision on any increases in tuition for the following school year.**
8. To qualify for **CATHOLIC FAMILY IN-PARISH TUITION RATES**, a family must be registered in one of our eight supporting parishes, have a parish verification form signed by your pastor and filed with our school prior to the start of the school year, be practicing Catholics and participating in the life of the parish and community, and contributing to your parish offertory collection. This may be reviewed on an annual basis at the discretion of the pastors of our sponsoring parishes.
9. It is further understood that the student and student's parents/guardians will abide by the policies and guidelines documented in the School Student and Family Handbook.
10. **Family Involvement Program-** All families with students enrolled in Most Blessed Sacrament Catholic School are expected to participate in 20 hours of service by May 31st of the calendar year. Those families who cannot participate in service time have the option of buying their service time hours at the rate of \$20.00 per service hour. Any service hours not completed will be charged a \$20.00 per hour fee.

Once a student is registered in our school, you have entered into an agreement and commitment to pay tuition for the entire year. The size of staff, amount of materials and books, and yearly school budget are based upon this commitment which was made at the time of admission/re-enrollment. Tuition paid is nonrefundable, and paying tuition is the obligation of the family.
